After having been the driving force of the Climate Change and low carbon economy agenda under Barroso I and having launched, under Barroso II, the Resource Efficiency Revolution (including Cradle to Cradle, Bioeconomy and Blue Economy), the Environment Council, by launching the 7th EAP co-decision process should, prior the European elections 2014, take the lead of the Good Life for All Revolution and the Participatory and Contributive Democracy Revolution for an Innovative and Resilient Europe

A 7th EAP should include the Resource Efficiency Roadmap and be the 'overarching legal basis' adopted by the Council and the Parliament and fixing

a Commission ten years action programmes building on a 'Vision 2050' and The seven thematic strategies of the 6th EAP

and

3 Pillars of Action of the 'EU Transformation Agenda' :

- Innovative and Resilient Europe and the 7 Revolutions linked with Europe 2020 Roadmaps related to "efficiency", i.a Resource Efficiency, Renewable Energy and Energy efficiency, Bioeconomy & Green Chemistry, Transport, Biodiversity, Water (using only know-how and technologies which are environmentally sound and socially acceptable)**
- Good Life for All, a societal contract i.a. lifestyles and consumption patterns, prices and environmental justice, environment and health**
- Participative and Contributive Democracy, i.a. for a green economy and poverty alleviation in knowledge and collective intelligence societies**

INTEGRATION

Sustainable development calls for an integrated approach to create sustainable communities, cities, enterprises 'sharing values' :

the 7th EAP should not be limited to DG Environment and DG Climate agenda's but address as well the integration of Environment by being linked with the time frame and the greening of the EU Budget (2014–2020) as well as policies related to taxes, health, agriculture, industry, transport, energy, development etc.

7thEAP Co-decision : Policy Instruments gaps towards a Resilient Europe, creative resistance, transformative vision, anticipatory experiences :

Common goods	Identify, protect, enhance common goods in a biosphere era. Market mechanism not adapted. Polycentric management. (Nobel Prize Elinor Ostrom)
Collective rights	Collective rights are recognized in the Charter of Fundamental Rights to employers and trade unions (art. 28) Class action for environment protection ?
Communities support	Collaborative Organisation are more resilient. Support anticipatory experiences. Empower communities to contribute to the implementation of environmental policies objectives
Crowd Sourcing	Open-space creating shared values, trust, solidarity and hope needed to be creative and resilient
Covenants	Cooperation agreement for a scale effect at EU and other levels based on market actors rights and responsibilities and inspired by Compacts and Covenants already adopted at EU level (Covenant of Mayors) Member State (UK, Estonia, France, the Netherlands) and/or Regional levels (Scotland, Northern Ireland, Wales),

The 7th EAP should be the framework basis to develop polycentric tools to strengthen action at Member State and Local levels to protect the common goods

- Local Climate and Air Quality Action – with a strategic framework and tools for citizens empowerment and local governments action to quantify their emissions, to set reduction targets and to implement and monitor these targets.
- Local Water Action – in view of securing water access and systematic identification and evaluation of water resource management challenges facing local governments and communities contributing to the WEHAB Water & Sanitation and Health agendas.
- Local Land and Soil Action –land use management and soils protection
- Local Biodiversity Action –

- ecoBudget® as a mechanism established parallel to financial budgeting that ensures the ongoing control of environmental quality and the use of natural resources through the annual setting of targets, controlling and reporting.
- ESG monitoring, reporting, rewards, providing information on social, economic and environmental performance and accountability of companies and public authorities decision makers and management.
- EU Funding support linked with Covenants.

NGO's	Failure to mobilise citizens purchasing and investment power, their 'other voting right'

Responsible Investment/Green banking	Failure to coordinate (even cooperative banks) and failure to create a scale effect
EU and Governments	Failure to change deeply the tax system
